IECC 2024 - 2 Day Seminar

Program:

Day 1: Wednesday 5/14 - Significant Changes to the 2024 IECC - Residential Provisions

This class will assist participants in implementing the transition from the 2021 International Energy Conversation Code® (IECC®) to the 2024 edition. Course material will focus on specific key changes that have occurred in the IECC - Residential provisions, the reasoning behind the changes, and their effects on the implementation and enforcement of the energy code. Participants will gain knowledge of new and updated topics including third party inspection agencies, residential performance testing, additional energy efficiency credits, and requirements for the performance compliance paths.

Day 2: Thursday 5/15 - Significant Changes to the 2024 IECC - Commercial Provisions

This class will assist participants in implementing the transition from the 2021 International Energy Conversation Code® (IECC®) to the 2024 edition. Course material will focus on specific key changes that have occurred in the IECC - Commercial provisions, the reasoning behind the changes, and their effects on the implementation and enforcement of the energy code. New topics incorporated into the 2024 IECC will be discussed including thermal bridging, total system performance ratio, and renewable and load management credits.

Participants will receive a broad overview of the IECC, including its scope and application, to provide context to the topics under discussion.

This will be an ICC accredited seminar with .6 ceu credit hours each day for ICC members only.

Jerica is the Director of Technical Training at the International Code Council where she supports the Code Council's energy code and sustainability initiatives, contributes to energy codes and standards technical development, and advances the Council's business interests related to energy codes and standards for both the national and international markets. Jerica works closely with the Code Council's Sustainability Membership Council as its staff liaison; serves on the RESNET Standard Development Committee 900 which oversees RESNET's quality assurance and sampling technical standards; participates in ad hoc committees and task groups related to energy code compliance and enforcement; and is an active member of the Idaho Energy Code Collaborative where she supports energy code education in her home state.
